Premise

In implementation of the provisions of EU Privacy Regulation 2016/679, Valmed Srl (hereinafter also referred to as “the Controller”) provides you with the required information regarding the purposes and methods of processing your personal data, as well as the scope of their communication and dissemination, the nature of the data in our possession and their provision in relation to the contractual relationship.

1. Data subject to processing

The Controller will process common personal identification data (for example, first name, last name, company name (registered name), address, telephone, e-mail, bank and payment details—hereinafter, “personal data” or simply “data”) that you have provided.

2. Lawful basis for processing

Your data will be processed on the basis of Art. 6, paragraph 1

- letter b) — for the performance of a contract to which you are party or in order to take pre-contractual steps at your request;
- letter c) — for compliance with a legal obligation to which the Controller is subject.

3. Purposes of processing

Your data are processed for the following purposes:

- proper performance of supply contracts and services;
- fulfilment of legal obligations, including tax, accounting and administrative obligations, also towards the tax authorities;
- internal organisational purposes such as indicators of the effectiveness of managing commercial relationships with suppliers, connected with the performance of the contract;
- the exercise of a right or legal claim.

4. Methods of processing

The processing will be carried out in compliance with the aforementioned purposes and as provided by Art. 4 of the Privacy Code and by Art. 4 No. 2 of the Regulation, with or without the aid of electronic tools by the Controller and/or the company’s employees and/or collaborators specifically authorised for this purpose, and consists in particular of:

- a) the collection of personal data;
- b) the archival retention of documents received and required for the performance of contractual services;
- c) the entry/updating and organisation in the database in both electronic and paper form;
- d) the consultation of the data;
- e) the processing of the data to enable the achievement of the purposes indicated above;
- f) the interconnection and/or comparison of the data;
- g) the erasure and/or destruction of the data.

The operations referred to at points b), c), d), e) and f) will also be carried out, for the proper pursuit of the purposes, by the processors appointed and by authorised personnel.



- to request a copy of the protection measures prepared with regard to the transfer of data to third countries, if applicable;
- to receive, in a structured, commonly used, and machine-readable format, the personal data concerning you and to transmit those data to another Controller, without hindrance from the Controller to which you have provided them, in certain cases (Right to data portability Art. 20);
- to object at any time, on grounds relating to your particular situation, to the processing of personal data concerning you (Right to object Art. 21);
- to be notified without undue delay of the personal data breach suffered by the Controller (Art. 34);
- to withdraw consent given at any time (Conditions for consent Art. 7 and Art. 13);
- to object to a decision-making process relating to natural persons based solely on automated processing, including profiling.

Requests will be fulfilled within 30 days. This period may be extended for reasons relating to the data subject's specific right or to the complexity of your request. The data subject is informed that they have the right to lodge a complaint with the Italian Data Protection Authority, following the procedures and instructions published on the Authority's official website at www.garanteprivacy.it, and that the exercise of rights is not subject to any formal constraint and is free of charge.
